

The Chennai Angels – Applying for funding

Entrepreneur Guide

What is our process?

The Chennai Angels follows a four step process: Initial Screening, Deep Dive, Presentation and Due Diligence. Entrepreneur Applications are normally taken up for initial screening on Fridays, and should we decide to do a deep dive, we will be in touch with you on the following week. Additional information may be required for Deep Dives, which our Deep Dive Champion will seek from you via phone calls and emails. A Deep Dive is typically to a maximum of one hour long call or a meeting followed by extensive research from our side.

Once the deep dive is completed, if we move forward, we will be inviting you to make an in-person presentation to the Angels on a Saturday, normally the Second or the fourth Saturday. Prior to that we will request you to fill the first two sections of our online application.


If we move forward after the presentation, we will appoint a Deal Champion who will guide you through subsequent steps. While we do desire to complete the process and have funds dispersed to you at the earliest, it typically ends up taking 8-12 weeks after the presentation for that to happen. At the time of Due Diligence we will send you a link to update yet more information on the Platform.

How to apply?
